

hospital Ram was seen by Dr. Smith p.139 at 4.05 am. Ram gave a false name was abusive and inebriated and could not be treated. At 5.30 am Ram agreed to be treated and had 3 sutures inserted into the laceration in his left cheek. Thereafter they obtained a lift in a taxi driven by Mr. Lincoln Dunkley p.137 to Archibald Road, Lozells. During the journey Mr. Dunkley heard words like "London" and "passport" and Shinji say "Don't forget to let me know when to pick you up". At Archibald Road, Shinji got out and the taxi then continued to Ashwin Road where Ram paid the fare.

(c) The deceased was taken to Birmingham General Hospital. In spite of the efforts of Dr. Jeanne McGovern p. 101 he died and was certified dead at 4.23 am by Dr. Growson p.104.

(d) The post mortem was conducted by Dr. Norman Grower p.106. Death was due to

(a) haemorrhage

(b) penetrating wound of the chest. (Post mortem photographs Exhibit 5)

(e) Photographs were taken of the restaurant to show the scene Exhibit 4

(f) At about 8.30 am Inspector Ratcliffe p.122 and D.C. Whild p.113 found a trail of blood left by Ram as he fled the scene. They followed it. See Exhibit 3A (p.4) along a series of back streets to the junction of South Road and St. Michaels Hill where persistent rain destroyed the trail.

8. Arrests and Interviews

(a) Shinji surrendered himself at Steelhouse Lane police station on Sunday 16.11.86. He was interviewed (not under caution) Exhibit 15 (p.22) He admitted he was present at the stabbing but gave a false account of the route taken to Soho Road (p.46-47). A witness statement was also taken Exhibit 16 (p.52).

(b) Ram surrendered himself at Steelhouse Lane Police Station on Monday 24.11.86. He was arrested on suspicion of murder ^{and interviewed} Exhibit 18 (p.54). He admitted involvement but claimed he produced the knife in self defence and only stabbed out once.

(c) On the 9th December 1986 Shinji was seen by the Police by appointment at Bridge Street Police Station. He was interviewed Exhibit 19 (p.70). He admitted that he lied about the route taken from the restaurant following the stabbing but claimed he did so because he did not want to get involved (p.73). He denied suggesting they used the back streets (p.74). He said he accompanied Ram because he was worried about his loss of blood (p.75). He was charged with Count 2 on 29th January 1987.

REGINA -v- SATPAL RAM
NAVINDER SINGH SHINJI

The Defence on behalf of each Defendant admit :-

1. The Plans Exhibits 1, 2, 3 and 3(a) and the facts marked thereon.
2. The photographs Exhibit 4 which were taken on the 16th November 1986 and the photographs Exhibit 7 which were taken on the 24th November 1986 and are of the Defendant Ram.
3. That the lighting inside The Sky Blue Restaurant at the time of the stabbing was subdued.
4. That the Police arrived at the restaurant at 2.40 a.m. on the 16th November 1986 following the stabbing.
5. That the ambulance arrived at 2.46 am and took Pearce direct to The General Hospital, Steelhouse Lane, Birmingham, where he arrived at 2.54 am.
6. That at the hospital Pearce was in shock and was extremely uncooperative with medical staff.
7. That Pearce died from his injuries at 4.23 am the same day.

8. That following his death samples of blood and urine were taken . These samples were analysed and showed

(a) Blood: 189 milligrammes of alcohol per 100 millilitres of blood. (Legal limit for driving is 80).

(b) Urine: 168 milligrammes of alcohol per 100 millilitres of urine (Legal limit for driving is 100).

9. That at 3.42 am the Police discovered a trail of blood leading from the restaurant into Wheeler Street. At 9.45 am the Police followed the trail of blood as far as the junction of South Road with St. Michael's Hill in accordance with the route shown on Exhibit 3 (a).

10. That the name Afzal Saleem and the d.o.b. 3.10.65 provided by Ram to Dr. Smith at Sandwell General Hospital, West Bromwich belongs to a friend of Ram's called Mohammed Afzal Saleem, a refrigeration Engineer of 43 Holly Road, Handsworth.

11. That Ram surrendered himself at Steelhouse Lane Police Station, Birmingham at 4.05 pm on the 24th November 1986. He was arrested on suspicion of murder.

12. The ~~murder~~ weapon has never been found.
