I said to RAM, "I am DC RICHARDS, I am formally telling you that you are being arrested on suspicion of Murder".

I then cautioned him, RAM nodded and made no reply.


RAM was then escorted to the Custody Area.

I was later present when RAM was examined by Dr D. W. KETT in the Doctor's Room at Steelhouse Lane Police. Dr KETT obtained a blood sample from RAM which he handed to me at 20.10hrs that day.

 I later handed to Detective Constable MOORE.

I was later present when RAM was formally charged with the Murder of Clorise Edward PEARCE to which he made no reply.


Continuation of statement of John Riccardos
